Company History

AutismPro provides a 21st century response to the challenges of educating students with autism called *AutismPro*. The company works with school districts, early intervention providers and governments to supplement quality programs.

- Cynthia Howroyd, a speech-language pathologist and clinical director, created *AutismPro* to provide efficient and affordable guidance to professionals working with children with autism.
- The goal in developing *AutismPro* was to leverage technology to address the ongoing challenges and issues related to the treatment of children with autism.
- Understanding how the expertise of professionals, the Internet, software, and online learning could be combined in a single solution, Howroyd developed the vision of a “virtual autism clinic” that would dramatically increase accessibility to treatment guidance.
- AutismPro (Virtual Expert Clinics, Inc.) was established in 2004.
- As a result of strong interest from school districts and early intervention centers, AutismPro developed a package of software, consulting, training, and program-design services to help these institutions deliver autism programming to improve child outcomes.
